Participants should bring sample-sized servings of specialized dishes that represent your restaurant. These might include appetizers, entrees, salads or desserts. Service is done buffet-style from your station. You should package/present your items as individual servings and provide eating utensils as needed. No alcohol permitted! We anticipate 400 attendees.

You will be provided with two 6-foot tables under a canopy. We will also have hand washing and ware washing stations for participants to share. You must bring all safety and serving equipment, including hand and face coverings, and all other sanitary items as required to serve outdoors per the Sussex County Division of Health, including any State of NJ guidance for outdoor dining which may be in place at the time of the event. You may also bring tablecloths, decorations, and marketing materials to promote your establishment.

ALL PARTICIPANTS MUST REGISTER WITH THE SUSSEX COUNTY DIVISION OF HEALTH BY AUGUST 12. Please submit the temporary food vendor application & appropriate fee directly to the County. See attached application.

A **\$100 refundable deposit payable to ‘GNCC’ is required at the time of registration**. This will be refunded to you immediately following your successful participation in the event. Restaurants that are no-shows or depart early will not have their deposit refunded. **We also require proof of general liability insurance**. You do not need to name us as additional insureds; we simply need proof of coverage (i.e. a copy of your Certificate of Insurance) for your establishment.

Restaurants may begin setting up at 3:30 PM, must have cars moved by 4:30 PM, and must be completely set up by 5:00 PM. Service begins at 5:30 PM sharp and ends at 8:30 PM. We ask that you remain serving at your station for the entire event. Restaurants that break-down their stations prior to 8:30 PM will not have their deposit refunded.

Participating restaurants will receive up to 6 Vendor Tickets for your staff to use during the event, provided on site.
